RULES & REGULATIONS

For Admission :

1. Only those applications, who fulfill minimum qualification will be considered
2. Mere Possession of the qualification does not itself entitle a candidate to be considered for admission.
3. The management of the school reserves the right to change the number of seats or number of sections in any class at any time without any prior notice.
4. After the admissions are closed for a particular class, waiting list of registered and qualified candidates shall be maintained for any 'chance vacancy' that may arise during the course of academic year.
5. Only short listed Candidates will be admitted. They have to submit the original school-leaving certificate and original Markscard at the time of admission or before 20th May of the calendar year.
6. The selected candidate will have to under go medical checkup/fitness by the prescribed Medical Officer of the Institution.
7. The Head of the institution reserves the absolute right at his discretion to cancel the registration of any student from the roll of the school if he is not satisfied with academic progress or general conduct of the student and/or for any of the following reasons.
 - a) Absence without sanction of leave for more than 4 days during the entire term the school.
 - b) Failing in the same class during course of his study in the school.
 - c) Indulgence in indisciplined act or serious breach of trust for adopting unfair means in tests and examinations.
 - d) Failing to pay the fees in time.
8. If found, at any later date that any of the information furnished by the parent/guardian in the application form is false, the institute will have the right to cancel the admission at any stage and forfeit the fees and deposits.
9. In the matter of admission, the decision of selection committee shall be final and binding to all concerned parents/guardians.
10. Third language is an examination subject. A pass in the subject is compulsory for promotion.
11. A student, while travelling by school bus, if he / she meets with any accident, the institute will provide him / her the available best possible medical treatment, care and attention to him / her. But in spite of that if anything adverse happens to him / her including loss or damage of temporary or permanent nature consequently to that, the institute in no way shall be responsible for the same.

For Payment of Fees :

1. The fees once paid shall not be refunded or transferred.
2. Payment of fee shall be paid in cash or by Bank Draft in favour of JAI TULSI VIDHYA VIHAR payable at Bangalore. Cheques will not be accepted.
